Whether, in regard to the structural economic vulnerabilities identified in the 2023 Mauritius Economic Report of the World Bank, she will state the measures Government proposes to take to attract Foreign Direct Investment in emerging sectors, including through tax incentives, subsidies and Public-Private Partnerships?

**Questions addressed to the NYP Prime Minister, Minister of Defence,
Home Affairs and External Communications, Minister for Rodrigues and
Outer Islands**

B/1 The Member of the National Youth Parliament (**Ms Kulpoo**)

To ask the NYP Prime Minister, Minister of Defence, Home Affairs and External Communications, Minister for Rodrigues and Outer Islands –

Whether, in regard to the prevailing law and order situation, he will, for the benefit of the House, obtain information as to the strategic priorities under consideration to further reinforce same, indicating how emerging technologies and best practices can be integrated to meet evolving security challenges?

B/2 The Member of the National Youth Parliament (**Ms Rock**)

To ask the NYP Prime Minister, Minister of Defence, Home Affairs and External Communications, Minister for Rodrigues and Outer Islands –

Whether, in regard to maritime and air connectivity, he will, for the benefit of the House, obtain information as to the projects and initiatives being envisaged for the strengthening thereof for the economic and strategic benefits of Mauritius, regionally and internationally?

B/3 The Member of the National Youth Parliament (**Ms Teeluck**)

To ask the NYP Prime Minister, Minister of Defence, Home Affairs and External Communications, Minister for Rodrigues and Outer Islands –

Whether, in regard to narcotics trafficking, synthetic drug consumption and the resulting public health and socio-economic risks, he will, for the benefit of the House, obtain information as to whether consideration will be given for the taking of appropriate legal and other measures to effectively and efficiently deal therewith in a wholesome manner, including the establishment of a National Drug Rehabilitation and Reintegration Authority?

B/4 The Member of the National Youth Parliament (Mr Mudalli)

To ask the NYP Prime Minister, Minister of Defence, Home Affairs and External Communications, Minister for Rodrigues and Outer Islands –

Whether, in regard to law and order, he will, for the benefit of the House, obtain information as to the measures being envisaged for the (a) modernisation of the investigative powers (b) enhancement of the Forensic Science Laboratory and (c) embedding of intelligence-led policing whilst ensuring the alignment thereof with the obligations of Mauritius under the International Covenant on Civil and Political Rights and the United Nations Guidelines for the Prevention of Crime?

B/5 The Member of the National Youth Parliament (Ms Larose)

To ask the NYP Prime Minister, Minister of Defence, Home Affairs and External Communications, Minister for Rodrigues and Outer Islands –

Whether, in regard to the long-term vision for the Island of Rodrigues and the Outer Islands, he will state the strategic projects under consideration to strengthen infrastructure, economic resilience and social wellbeing thereat?

B/6 The Member of the National Youth Parliament (Mr Young Pak Kian)

To ask the NYP Prime Minister, Minister of Defence, Home Affairs and External Communications, Minister for Rodrigues and Outer Islands –

Whether, in regard to floods, he will, for the benefit of the House, obtain from the National Disaster Risk Reduction and Management Council and the National Disaster Risk Reduction and Management Centre, information as to where matters stand regarding the creation of a comprehensive plan to guide the implementation of disaster risk reduction and management strategies in terms of specific long-term infrastructure upgrades and their completion timelines to (a) prevent the recurrence thereof (b) carry out audits thereof and (c) hold agencies to account for lapses identified during same?

To ask the NYP Minister of Land Transport –

Whether, in regard to traffic congestion, he will state if a sustainable mobility framework is being envisaged for the prevention thereof, indicating the measures being envisaged to implement an integrated transport plan, expand public transport options and encourage a shift from private to public and active modes of transport?

To ask the NYP Attorney-General –

Whether, in regard to the judiciary, he will, for the benefit of the House, obtain information as to where matters stand regarding the initiatives undertaken for the digitalization of the court processes and case management, indicating the expected service delivery outcomes thereof in terms of efficiency and reduction of delays?

To ask the NYP Minister of Local Government –

Whether, in regard to the local authorities, she will state the measures being taken to strengthen compliance with good governance principles across same while safeguarding the administrative autonomy thereof?

To ask the NYP Minister of Foreign Affairs, Regional Integration and International Trade –

Whether, in regard to the African Continent, he will state the steps being taken by Mauritius to strengthen its diplomatic presence therein and deepen bilateral ties with individual countries thereof, including ensuring meaningful Youth Exchange Programmes?

To ask the NYP Minister of Arts and Culture -

Whether, in regard to the cultural and creative sectors, she will state the initiatives being envisaged to (a) encourage private sector participation therein (a) expand the creative economy by 2026 and (c) convert cultural assets into sustainable livelihood for artists nationwide?

To ask the NYP Minister of Health and Wellness -

Whether, in regard to e-Health, he will state the measures being envisaged to introduce and expand digital health cards, telemedicine, e-prescriptions and online booking systems, indicating how (a) high standards of data security and patient confidentiality will be ensured and (b) Mauritius proposes to position itself as a regional model therein?

To ask the NYP Minister of Commerce and Consumer Protection –

Whether, in regard to the trade deficit, as reported in May 2024, she will state the measures being envisaged to diversify the export sector with a view to (a) improving the trade deficit and (b) reducing over-reliance on imports?

To ask the NYP Minister of Youth and Sports –

Whether, in regard to the practice of sports disciplines, he will state (a) if an assessment of youth participation therein has been carried out and, if so, indicate the (i) outcome thereof and (ii) strategies put in place, if any, to boost same, including through the facilitation of emerging sports disciplines and implementation of digital platforms and (b) how public sports infrastructure is being utilized?

To ask the NYP Minister of Tourism –

Whether, in regard to the United Nations' Sustainable Island Mauritius (SIM) Project and the Government's 2025-2029 Plan, she will state the incentives provided thereunder to promote green tourism and increase local community participation in related activities in rural and coastal areas, indicating the expected contributions thereof to sustainable economic growth?
